MINUTES APPROVAL: April 17, 2020.

Mahesh Albuquerque motioned approval and Susan Demueles seconded. Minutes were approved unanimously.

### STAFF REPORTS

- March 2020 72 claims received, \$1.3 million requested, \$853,000.00 reimbursed.
- Fund Balance \$3.3 million as of May 13th, average processing turnaround time of 47 days for FY20.
- Applications not yet presented 2 applications from last half of 2019, one will be heard today.
   33 applications from 2020, 12 of them are scheduled for this meeting.
- Susan provided a general report about Fund Balance and projections:
  - o Beginning of the month balance for April 20' was \$1,499,000.00.
  - April 30th OPS received a \$3,000,000 deposit of the environmental surcharge.
  - o OPS has approved \$2,000,000 in RAPs and \$730,000. in State Lead payments.
  - o OPS is being conservitive with payments until further Fund balance figures are acquired.

#### REASONABLE COST GUIDELINES UPDATE

Due to the ongoing Covid-19 situation, budgetary shortfalls, and Fund solvency issues OPS will not be able
to provide any adjustment to Reasonable Cost Guidelines at this time. This will be reevaluated at the end of
2020, into 2021.

#### **OPS UPDATES/ANNOUNCEMENTS**

- Mahesh provided a general report about OPS operations during the COVID-19 health crisis:
  - OPS is working with the Joint Budget Committee and Stakeholders to propose a bill that will help the division to continue payments to applicants and consultants. This bill would allow money from the PCRF to be transferred to the PSTF.
  - OPS Inspectors are starting to head back into the Field to continue inspections.
  - o OPS Offices are still closed to the public. A soft opening might occur in June.
  - 60 Day compliance extensions granted in March & April are now nearing expiration. If an Owner/Operator needs an extension on any compliance deadline, they will need to contact staff to request the extension. These will be considered on a case by case basis.
  - A Stakeholder meeting will be held on June 3, 2020 at 1:00 PM.
